



### ***"Sally Glei and Friends" Workshop***

Cannon and I attended a two day obedience workshop at Merrimac Dog Training Club Hampton in July. The workshop instructor was Sally Glei. If you are interested in competitive obedience or improving your relationship with your dog for other sports, do yourself a favor sign up for a Sally Glei clinic. It was outstanding! Merrimac DTC did a very good job in having the facility ready, being organized, and starting on time. I would give them their highest marks on limiting the number of participants to ensure every dog and handler "team" was safe and received one on one instruction. 20 participants and dogs were accepted, the group was split in half with color coded dots, and Mrs. Glei had five assistants do the math that's two "teams" per instructor. It was wonderful. Mrs. Glei and her assistants excel in competitive obedience but their focus is on FUN.

We started off our Saturday morning with play exercises. That's it, just play ten "teams" for five minutes just playing with the dog. Then we switched with the other ten. Some dogs were really in to it others, like mine were wondering "what the heck the wild dogs were doing". And the boom box was booming. Mrs. Glei believes in playing music that lifts your spirits and puts a smile on your face while you train, and allows the dog to get used to all sorts of noise. It was a dog party I'm telling you. Even Cannon got into it! Play was used in every exercise from attention, to tighter heeling, to dumbbell relays. I was exhausted by the end of the day Saturday, but was really looking forward to Sunday. Sunday was just as much fun as Saturday, covering the more advanced levels of obedience but worthwhile for even we novice folks. Even if Cannon and I couldn't participate in the "Dumbbell Relay" game I learned something from it and all the dogs were watching and barking and having a great time.

All in all a VERY POSITIVE experience my goals are to play with my dog more and be more consistent in "marking" the behavior I want. I'm trying to drop all the happy clappy "way to go", "that's what I want", "good job" and replace it with one word, YES. Just like a clicker but you don't have to dig in your pocket for it. I can tell you it has made a difference. And I am using YES with my puppy when I practice "who wants to be a show dog" at home with my grooming table. It's hard to keep my mouth shut I know it's hard to believe! but limiting all that babble does help.

So once again, if you get an opportunity to attend a Sally Glei workshop, GO! Pay the money, it was 125 for the weekend and it was worth every penny. Never have I seen that many happy dogs in one place.

Here's to a smile on YOUR face as you train and dogs who think work is PLAY!

If you became ill or died tomorrow, what would happen to your dogs? Could they be neglected or mistreated? Would they end their days at a humane society? this fear caused me sleepless nights.

We breeders have the greatest cause for concern. Although a relative or friend might care for one or two pets, we can't expect them to adopt five or ten or more. difficult as this might be to think about, I don't want my animals to suffer because of my procrastination.

With frequent trips to judge, give seminars, or show my own dogs, I wanted to protect my canine traveling companions. I made copies of the document below for each vehicle and my tack box.

## *Statement of Intent*

In the event that I, \_\_\_\_\_, become incapacitated and unable to make my wishes known regarding my SHOW dog s , please honor the following requests:

- \_\_\_\_\_ is to be contacted as soon as possible at \_\_\_\_\_ please call collect . If she/he cannot be reached, please contact \_\_\_\_\_. All expenses for the dog s care will be guaranteed by them.
- If the dogs are not injured, they are to be cared for by the nearest reputable boarding kennel and be kept in the best possible manner until arrangements can be made to get them home.
- If the dog s are injured, they are to be cared for by the nearest reputable veterinarian. I would prefer that my veterinarian, \_\_\_\_\_ phone \_\_\_\_\_ , be contacted regarding decisions on the dog s ' care and treatment. If any dog s are injured beyond all hope of recovery, those dogs are to be humanely euthanized.
- Descriptions of the dog s are attached, as are their health and vaccination records.

The welfare of my dog s is my primary consideration.

On the back of each copy, I typed my dogs' names and a brief description, with a statement that all vaccinations are up to date. I then laminated the copies.

## *Statement of Intent*

For more permanent foster care, I have attached a statement of intent to my will. Because it's possible for dogs to become senior citizens by the time probate is completed, I've spread copies around like a puppy in a pile of leaves. One copy is in a drawer with all the individual dogs' folders. My daughter has one, as does my vet and another good friend. i update the statement periodically ideally, when I add a new dog. But, at the very least, I make changes annually when I do my taxes.

First, I found someone willing and able to distribute the dogs among friends who could care for them temporarily. My daughter knows our pets well and agreed to help place them. While in most cases a friend

would likely have better access and knowledge to place the dogs, friendships can change. Relatives don't. Of course, when contacted, most friends would immediately help, if not actually take over the chore, during such an upsetting and traumatic time.

At first I wanted my youngsters to be placed with someone who would show and breed them to continue my line. Then I realized it wouldn't make much difference if I were dead. I would want them to continue living in the style to which they've become accustomed with comfy beds to nap on, snacks during dinner preparation, a loving touch, and good physical care. If that includes showing and breeding, fine. But the priority is to ensure as few changes as possible and that my pets have loving homes.

Some dogs may have difficulty adjusting. Or it may be almost impossible to find them a good home. These can include very old dogs, ones with chronic illness or disease, or those too shy or aggressive to change their allegiance. Rather than having them end their days bewildered or in fear, I have directed that they be euthanized.

Although a similar instruction was overturned by a court in California, this can be avoided if you use a statement of intent rather than a will. I instructed that my dogs be placed in my daughter's care with the stipulation that if she were unable to care for them or find them homes, they'd be euthanized. My vet knows and would acquiesce to my wishes. So this would be fait accompli by the time a will could be overturned.

Then I found people who would give my dogs good homes. I know these friends will care for the dogs as I would. I also know that if they cannot keep the dogs, they will provide a loving foster home until they can find a permanent home, and that they'll be as selective in choosing an adoptive family for my dogs as they'd be when placing their own pups.

We elected to endow a small trust fund for each retiree those no longer bred. This helps cover not only food but medical expenses as the dogs age. Too large a trust can be challenged.

All of the dogs are listed with registered name, call name, description, year of birth, tattoo number and microchip if appropriate. A clause covering any other puppies or adults living with us at the time is included.

This statement of intent gives me peace of mind.

## ***Directions to Manakin Fire House***

From Interstate 64 Take exit #173  
Rockville/Manakin Rte 623 this exit is on the west side of Richmond, one exit west of the interchange for I 64 and 295 . Go South on Rte 623 if you are coming from the west on 64 it is a Right turn; coming from the east it is a Left turn Look for Texaco on your left and Amoco on your right to know you're going the right way! . Proceed on Rte 623 until it dead ends at Rte 250/Broad Street there is a Wachovia Bank on your left . Go west turn right onto Rte 250. Look immediately to turn Left on Rte 623 as it doglegs back at Red Oak Cafe. Once on Rte 623, you should see a sign for Veterinary Referral and Critical Care. Keep straight proceeding on Rte 623 until it dead ends at Rte 6/Patterson Avenue. Turn Right on Patterson Avenue and the fire house is less than 100 yards on your right. Go around to the back of the building to park. Meeting will be in the downstairs room around the righthand side of the building if you are facing it from the back parking lot.
